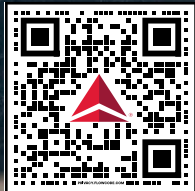

SUBMIT YOUR REQUEST: Make sure you're ready to begin the challenge before you submit your request.

CHECK YOUR INBOX: Keep an eye out for an enrollment confirmation email as your 90-day complimentary period begins within 24 hours after receiving this email.

KEEP EARNING TO EXTEND YOUR STATUS: Extend your Medallion Status through January 31, 2027 by completing the challenge requirements within 90 days of enrollment.

For a limited time, Southwest matches will be elevated one status higher than the equal Medallion Status.

*This limited-time offer provides a higher status match within the Status Match Challenge and is exclusive to Southwest Rapid Rewards® A-List and A-List Preferred members; offer valid on only submission requests received between March 24, 2025, and September 30, 2025.
